Were the materials and equipment carefully selected, neatly arranged and well-organized?(4 pts)</li> <li>6. Were charts and posters used if and when they were needed? (3 pts)</li> <li>7. (5 pts)</li> <li>5. Was the content appropriately related to the horse industry? (5 pts)</li> </ol>	25
<p><b>D. Stage Presence</b></p> <ol style="list-style-type: none"> <li>1. Was the presenter neat and appropriately dressed for the subject of the presentation? (2 pts)</li> <li>2. Did the presenter speak directly to and look at the audience? (5 pts)</li> <li>3. Was the presentation too fast or too slow? (3 pts)</li> </ol>	10
<p><b>E. Delivery</b></p> <ol style="list-style-type: none"> <li>1. Did the presenter appear to enjoy giving a presentation? (2 pts)</li> <li>2. Did the presenter have good voice control? (2 pts)</li> <li>3. Were all words pronounced correctly? (3 pts)</li> <li>4. Did the presenter seem to choose words at the time they were spoken as opposed to a memorized presentation? (3 pts)</li> <li>5. If notes were used, was it done without distracting from the presentation? (5 pts)</li> </ol>	15

<p><b>G. Summary</b></p> <ol style="list-style-type: none"> <li>1. Was the summary short and interesting? (2 pts)</li> <li>2. Were the key points briefly reviewed? (3 pts)</li> <li>3. Did the summary properly wrap up the presentation? (2 pts)</li> <li>4. Could the presenter handle questions easily? (3 pts)</li> </ol>	10
